Background of the Hospital

Bharatpur Eye Hospital; BEH (Hiralal Santudevi Pradhan Institute of Ophthalmic Sciences) is located in the Chitwan District of southern central Nepal. BEH is a non-profit making, charitable organization under the umbrella of Nepal Netra Jyoti Sangh (NNJS). Its objective is to provide highquality comprehensive eye care services at an affordable cost to local as well as patients from neighboring districts like Gorkha, Lamjung, Nawalpur, Tanahau, Makwanpur, Parsa & Dhading which comprises of about two million populations. In addition to Base Hospital located at Bharatpur Metro Municipality, BEH has established 3 Secondary Level Eye Hospitals and 18 Eye Care Centers at different places in its catchment area.

Bharatpur Eye Hospital was established in 1987. The hospital building was constructed with financial and technical support from the Bank of Commerce and Credits International (BCCI) Foundation Pakistan. The hospital was inaugurated jointly by the Late King Birendra Bir Bikram Shah Dev and the President of Pakistan, Ghulam Ishaq Khan on 31 March 1988. This was the only one eye hospital named after king, which was changed after Nepal attained Republic in 2008. BEH has an academic wing known as Hiralal Santudevi Pradhan Institute of Ophthalmology and is conducting residency in ophthalmology and fellowship programs in vitreo-retina and SICS in affiliation with the National Academy of Medical Sciences (NAMS). Similarly, it is conducting academic programs like Bachelor in Optometry (B Optom) under NAMS and Certificate Level in Ophthalmic Science under CTEVT Program.

Performance of Hospital in year 2022-23

OPD Performance

A total of **2,39,895** patients received eye care services from Bharatpur Eye Hospital (base hospital) and its networks that include secondary eye hospitals and eye care centers. Additional **96,257** patients were served through various outreach activities being conducted by Bharatpur Eye Hospital.



Surgical Performance

A total of **10,425** ocular surgeries of various categories were performed in the year 2022-23 at Bharatpur Eye Hospital and its Secondary Hospitals. Out of the total surgeries **9,197** (88.22%) were sight restoring cataract surgeries, including those performed through various DST and surgical camps.

Majority of the cataract surgeries performed in the hospital were phaco surgeries. **3,412** (32.73%) cataract surgeries were performed through various DST and surgical camps. Only 1,228 (11.78%) surgeries were other than cataract surgeries.

Specialty Services at BEH

Retina Department

The vitreo-retinal department of Bharatpur Eye Hospital was established in 2012 by Prof. Dr. Raghunanadan Byanju who is still the guardian for the progress of the department even after his retirement in 2021. The vitreoretinal department is combined with the Uveitis and ocular inflammation department and is jointly called the department of uveitis and vitreoretinal services. We have 2 consultants in the department who are trained in both departments, uveitis and vitreoretinal surgery. All standard equipment for patient care are available in the department as well as adequate training facilities.

The department has till date trained 6 fellows in vitreo-retinal surgery and has all handson training resources including teaching scopes in both the OPD as well as surgical microscope. It has facilities for green laser photocoagulation with additional facility of indirect laser Ophthalmoscopy. Also, the department of investigative ophthalmology includes a swept source OCT with OCT angiography along with fundus photography, Fundus Fluorescein Angiography (FFA) and high resolution ultrasound B-scan to support diagnosis and research in the department.


The Glaucoma Clinic remains committed to delivering the highest standard of eye care, research, and education, in line with our mission to preserve sight and improve the quality of life for our patients.



Cornea department is one of the well-established subspecialty department at Bharatpur Eye Hospital. Since corneal diseases is one of the major cause of blindness in developing countries, BEH cornea department has been providing services not only to the people in Chitwan, but also the its neighboring districts. The department is equipped with major investigative instruments for diagnosis and treatment of ocular diseases. There is also dry eye clinic within this department, providing dry eye therapy for the patients. In the year 2022-23, a total of 517 patient underwent investigations for dry eye and therapy for dry eye was done for 645 patients. The cornea collection center and the facility of cornea transplant has been started since 2017. In the year 2022-23, 2380 patients were treated at the department and a total of 505 cornea related surgeries were performed. Pterygium with graft is the major surgery performed followed by major and minor corneal repair procedures.

Oculoplasty Department

Oculoplasty is one of the subspecialties at BEH, dealing with the diagnosis and management of disorders involving the structures of the orbit, eyelids, tear ducts and adnexa. The Oculoplasty service is being provided by two Oculoplasty surgeons. Chalazion, Entropion correction and DCR are the common surgeries done. In this year 402 Surgeries were performed.




Investigation & Ocular Imaging Department



Low Vision Department

The low vision clinic is equipped with common low vision devices like monocular telescope, binocular telescope, spectacle magnifiers, and hand- held magnifiers, stand magnifiers, filters and non-optical devices. Low vision clinic has helped many patients to see better and use the residual vision to perform must needed daily activities. A total of 25 patients were provided low vision services in this year.





Contact Lens Clinic

Contact Lens are thin lenses placed directly on the surface of the eyes for refractive correction, cosmetic and therapeutic purpose. There are variety of contact lenses available based on its primary function, material, wearing and replacement schedule. Vision problems are pretty common in Nepal and people need some kind of vision correction device. Increasingly more people are turning to contact lens vision correction whether it is due to lifestyle or cosmetic reason.

In our hospital we provide services for the patient who wants Contact Lens for refractive correction, Keratoconous patient, patient having corneal problem with various lenses like power contact lens, disposable lenses, RGP lens, Bandage lens, and Toric contact lens.

A total of 118 patients took the contact lens service from the clinic in this year. The majority of the patients were prescribed soft contact lenses.

Outreach Eye Care Activities & Performance

Community outreach activities are the major activities of the hospital being conducted all the year round. In this year a total of 150 DST camps, 19 Surgical Camps, 11 DR camps, 136 school screening, 4 color vision test camps and 1 work place camp were performed. A total of 96,257 patients took their service through these outreach activities. 3,412 sight restoring cataract surgeries were performed through DST and Surgical camps, contributing to 37% of total cataract surgeries performed this year.

Newly Established Eye Care Centers

Three new Eye Care Centers :

- 1) Ishwarpur Municipality, Bayalbas, Sarlahi
- 2) Rapti Municipality, Bhandara, Chitwan
- 3) Aabukhaireni Rural Municipality, Aabukhaireni, Tanahun

were established in the year 2022-23 with a aim to provide primary eye care to the community people. The eye care centers have been established in collaboration with the respective municipalities and support from SEVA.





Research and Publications

Village Integrated Eye Workers Trial (VIEW)

This research project started in 2014 in collaboration with **University of California San Francisco, F.I. Proctor Foundation, SEVA Foundation** and Bharatpur Eye Hospital. Starting from the year 2014, VIEW has implemented different phase of its study activities (VIEW-I, VIEW-II Pilot, VIEW-II Screening, VIEW-II Final Exam- ongoing and SightLife blindness prevention program- ongoing). VIEW-I and VIEW-II Pilot is already completed and some of the papers have been published.

VIEW-II Screening:

This phase is the initial screening phase for VIEW-II from 2019-2023. This is cluster randomized trial to identify if an intensive screening with OCT and linkage to care can reduce the number of blindness due to Glaucoma, DR and ARMD compared to no intervention area in individuals 60 years and above. The final census will be done to find the cause of blindness in the community. Study area includes Bharatpur Metropolitan, Kalika Municipality, Ratnanagar Municipality, Khairahani Municipality in Chitwan district and Gaidakot Municipality, Devchuli Municipality, Kawasoti Municipality, Madhyabindu Municipality and Binay Triveni Rural Municipality-1 & 2 in Nawalpur District.

VIEW-II Final Exam: VIEW-II Final Exam is the wrap up exam of VIEW-II screening started from June 2023. A repeat census is conducted in all clusters 4 years after implementation of the screening intervention. Census workers update vital status and demographic data collected at baseline and add all new community members. Visual acuity is assessed for all participants ≥50 years old following the same procedures employed at baseline. Participants who have pinhole visual acuity worse than logMAR 0.48 (Snellen equivalent 20/60) in either eye at the time of the final census are offered an eye examination consisting of VA/refraction, IOP assessment, visual field assessment and anterior and posterior segment visualization at the community, performed by a trained team of optometrist and ophthalmic assistant masked to treatment assignment.

SightLife Blindness Prevention Program:

This aim to find the effectiveness of Female Community Volunteers (FCHVs) in preventing corneal blindness due to trauma. This was a three years study which ended in 2017 with the result that FCHVs intervention was effective in reducing corneal opacities due to ocular trauma in the rural communities than peri-urban or urban communities. Latter since September 2017 SightLife took this research as a corneal prevention program, where trained 117 FCHVs from 12 VDCs (Kathar, Kumroj, Birendranagar, Amarapuri, Pragatinagar, Devchuli, Agyauli, Deurali, Dhaubadi, Narayani, Nayabelhani and Kolhuwa) are involved in detecting and treating corneal abrasion due to trauma with prophylactic antibiotic oientment in their communities and appropriate referrals to eye care centers or eye hospitals. 4 field supervisors involved in monitoring those FCHVs.

SEVA : Call for Ideas Project

Bharatpur Eye Hospital in leadership with Dr. Manisha Shrestha. Pediatric **Ophthalmologist** and team were successful in receiving the award worth \$ 50,000 for SEVA'S CALL FOR IDEAS TO USE TECHNOLOGY TO EXPAND ACCESS TO EYE CARE SERVICE-2023." For the proposal of using optimum screening technology for diagnosing childhood vision loss in resource *limited settings*. In this project we are using screening devices, spot vision screener and bling to screen amblyopia and strabismus in the children aged 3-8 years and linking them to care. As a pilot project currently we are implementing the project in ward -5 of Bharatpur Municipality. This project was formally implemented in September 2023 and till date (February 2024) we have been able to screen 719 (84.98%) children out of 846. 144 (20.03%) kids have been referred out of which 94 (65.27%) of the kids attended the hospital for treatment.
